Since 2005 the organization has started working in South 24 Parganas district. SNP+ operates several programs to scale up services related to HIV prevention care, support and treatment. SNP+ is working in West Bengal and has developed the necessary networking and linkages with key stakeholders.

Since 2013, the organization has expanded its services to underprivileged children as well as care and support services, counselling, etc. to children in need of care and protection. # Program-wise Achievements



## Care and Support Centre (CSC) funded by WBSAP&CS

According to technical report India HIV/AIDS estimates, the adult (15-49 years) HIV prevalence in India is estimated at 0.31% in 2009 with approximately 2.4 million people living with HIV (PLHIV) within bounds of 1.93 to 3.04 million in 2009. Children under 15 years of age account for 4.4% of all infections, while people aged 15 to 49 years' account for 82.4% of all infections. Thirty-nine percent of all HIV infections are estimated to be among women. This amounts to 0.93 million women with HIV

in India. Care and Support programme is a national initiative to provide expanded and holistic care and support services to PLHIV. Care and Support Centres (CSC) established through SNP+, under the programme expand access to essential services, support treatment adherence, reduce stigma and discrimination, and improve the quality of life of PLHIV across **Howrah & South 24 Parganas** districts.

### Objectives of CSC:

- Early linkages of PLHIV to Care, Support and Treatment services.
- Provide differentiated care and support services to most needy PLHIV.
- Improved treatment adherence and education for PLHIV and addressing behavioural & social factors impacting adherence.
- Expanded positive prevention activities.
- Improved social protection and wellbeing of PLHIV.
- Early detection and management of co-infection-Tuberculosis among PLHIV.
- The project aims at improving linkage

to other social and health benefits provided by other line departments in line with local norms, regulations suitable for vulnerable populations.

- The Project aims at building a community model to address the complex needs of HIV prevention, care and support requirements in selected geographies.
- The project aims at reaching out to rural population who are vulnerable and are at risk of HIV/AIDS in a non-stigmatized enabling environment.
- The project aims at improving access to information materials, commodities (condoms, needles/syringes) through collaborating with nearest TI or government health facilities, testing and treatment services ensuring there is no duplication of services or resources.
- Strengthened community systems and reduced stigma and discrimination.

**Care and Support centres (CSCs)** are friendly places where PLHIV, key population members like FSW, IDU, TG, Hijra and MSM; women and children receive information on care and support, access to a range of health referrals, education and linkages to social welfare schemes and entitlements.

Apart from these, clients will be able to access the services of Drop-in centre like recreational facilities, entertainment etc. The team at the CSCs would also conduct home visits for the registered clients on their convenience and agreed timing to provide information and education on home-based care, adherence, any health referrals not only to the registered clients, but the family, which would be taken as a unit for information, education and referrals especially to social welfare schemes and entitlements.





## Link Worker Scheme (LWS) funded by WBSAP&CS

The project aims to halt, prevent and arrest the transmission of STI/HIV/AIDS among HRGs through a multi-sectarian response and improve the quality of life of people infected /affected by HIV through community-based initiatives in **South 24 Parganas District** at 29 blocks (100 villages).

### Target Groups:

- High Risk Groups:** Female Sex Workers (FSW), Men who have Sex with Men (MSM), People who inject drugs (IDU), TG (local),
- Highly Vulnerable Population:** Migrants (all categories), Truckers (all categories), Spouses of HRGs who also act as commercial partners.
- Vulnerable Population:** Regular partners and casual partners of Bridge Population. youth with STI, with high-risk practices, who are known to be clients of HRGs, who are HIV positive or TB patients, who are on ART are targeted more intensely.



### Objective of LWS Program

The Project aims at building a rural community model to address the complex needs of rural HIV prevention, care and support requirements in selected geographies.

The project aims at reaching out to rural population who are vulnerable and are at risk of HIV/AIDS in a non-stigmatized enabling environment.

The project aims at improving access to information materials, commodities (condoms, needles/syringes) through collaborating with nearest TI or government health facilities, testing and treatment services ensuring there is no duplication of services or resources.

The project aims at improving linkage to other social and health benefits provided by other line departments in line with local norms, regulations suitable for vulnerable populations.

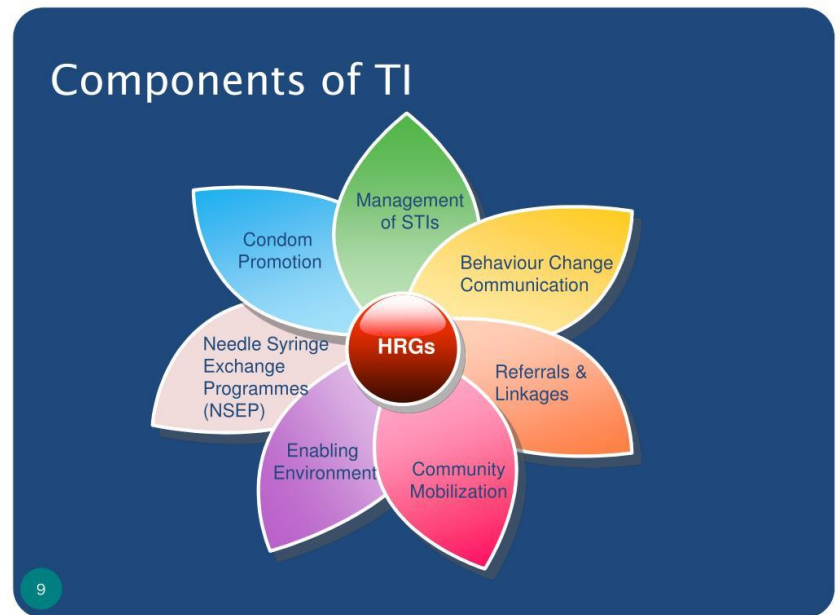

## Transgender - Targeted Intervention (TG-TI) funded by WBSAP&CS

The Transgender TI programme provides HIV related services to HRGs such as Hijra and Transgender in **Kolkata**. TIs provide a package of prevention, support and linkage services to a focused group of HRGs in a defined geography through a peer-led, outreach-based service delivery model in partnership with NGOs and CBOs. TIs have tried to reach a wider group of at-risk population such as spouses and partners of the HRGs. The primary prevention services like treatment for STIs, condoms, needles/syringes, BCC, enabling environment through community involvement and linkages with care and support services are provided to the target population under TI. These services have been prioritized for all the registered HRGs. Each TI offers a bouquet of services based on six components as through the figure highlighted at the right side.



## Objectives

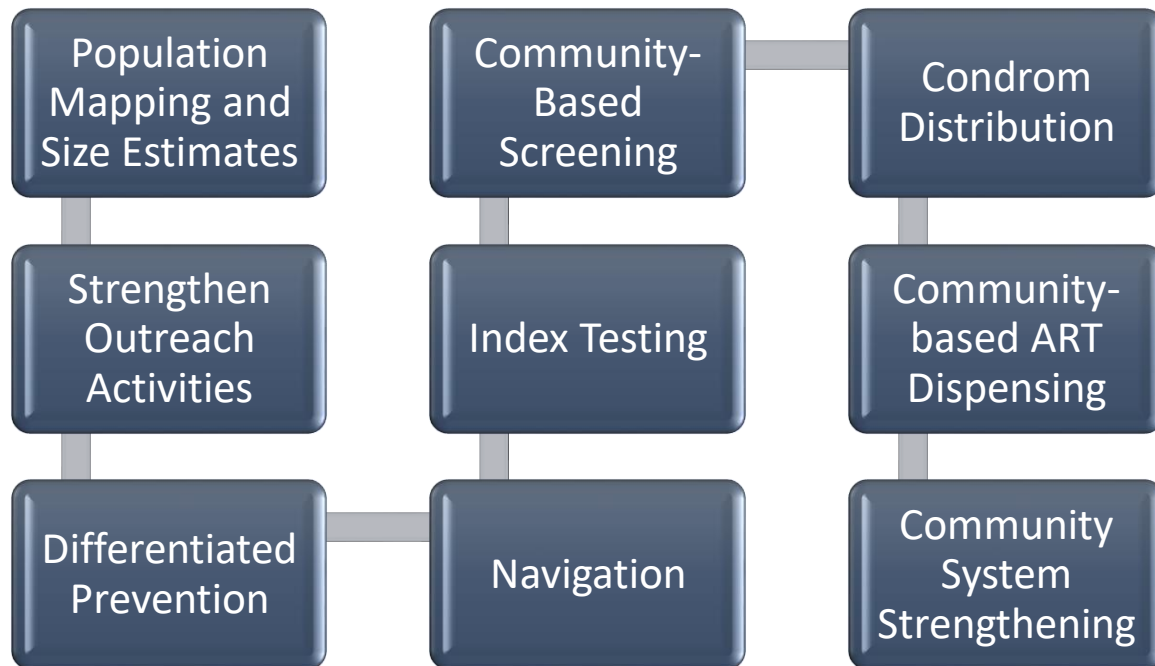
Empower TG/Hijras with knowledge, Skill and aptitude to protect themselves against HIV by provision of a scaled up and comprehensive package of prevention services

# Public Health Action (For PLHIV with TB Infection) under NTEP for TB Care in Kolkata supported by Kolkata TB Control Society & Kolkata Municipal Corporation (KMC)

PLHIV are the most vulnerable community who due to the low immunity status often falls into the clutches of TB. It is evident through many scientific researches & studies that PLHIV often has the history of recurrent TB. Close contacts living in close proximity of PLHIV are vulnerable in the matter of getting infection of TB which they are totally unaware of. PLHIV often receive counselling on HIV but not on TB in specific. As the PLHIV often has the number of episodes of TB their close contacts or the family members automatically gets frequent exposure to the air borne infection and falls into the risk zone of getting infected with TB. The risk gets double if the family members or close contacts having any co-morbidity apart from HIV or have an addiction in smoking. The proposed project aims strategic intervention on TB for People Living with HIV (PLHIV) availing treatment under **5 ART Centre's of Kolkata & their close contacts**.

GOAL

**Reduce the risk of TB among the people with comorbidity of HIV AIDS for smooth implementation of National TB Elimination Programme**

## Objectives of Kolkata TB program:

1. To reach out the PLHIV residing at Kolkata and out District through home visit.
2. To educate the PLHIV & their close contacts on TB & its relation with HIV in the ART centre.
3. To trace & search the close contacts of PLHIV infected with TB for presumptive identification.
4. To establish linkages with DTC to facilitate the screening & diagnosis of presumptive cases identified through contact tracing of PLHIV having TB.
5. To coordinate between DTC & ART centres to create the bridge.
6. To counsel & provide adherence monitoring support by the PLHIV to TB diagnosed patients infected with HIV.





## Sputum Sample Transportation Program

This program includes physical pick-up, transportation and delivery of biological samples along with required documents and reporting outlined by CMOH of **South 24 Parganas district**. The transportation of samples for TB testing requires cool temperature while transportation, timely delivery at right place and maintaining correct identification of samples while taking adequate biosafety precautions. While picking up samples, it must be ensured that the samples were packaged and stored in an appropriate manner before pick-up.

### Activities of the transportation program:

- Samples are usually collected from presumptive TB cases by ASHA in the community, Su-swasthyakendra (HWC) or nearest PHC by CHOs or ANMs when such cases come to HWC / Sub-centres and at any Health establishment (public or private).
- Samples collected at community levels are pulmonary ones, whereas samples at any health institutions may be Pulmonary or extra-pulmonary.
- From presumptive TB cases two samples are collected. These samples must be taken to nearest Microscopy or NAAT centre for diagnosing TB.
- If a positive result is obtained from the 1st sample, the 2nd sample is reflexly sent to another lab for further tests to know the drug resistance patterns.
- Some samples are transported from one Microscopy centre to another Health institution for NAAT testing.
- For LPA, Liquid culture and other tests some samples must be transported from Health institutions to Intermediate Reference Laboratory (IRL) at Belegghata, Kolkata.
- Two follow up sputum tests are done by Microscopy for Microbiologically confirmed cases during treatment. Number of samples collected for presumptive TB cases is two and that for Follow up is one.

## Rotary Literacy Mission

SNP+ implemented the Vidya' (EOTM) model for adult non-literate with a view to make them literate ("Project") with the mission of adult literacy in rural areas of **South 24 Parganas district**. Here the target population is the adult illiterate group and the mission initiated with 1064 learners of 30 centres.



### Objectives

- To read aloud at a speed of 30 (thirty) words per minute
- To read and understand Road signs, Posters, and newspapers
- To understand and copy 7 (seven) words per minute
- To take dictation at the speed of 7 (seven) words per minute
- To read and write numbers from 1 (one) to 10 (ten)
- To perform Simple Arithmetic Calculations





# Special Initiatives by SNP+

## World AIDS Day Observation

World AIDS Day 2023 is observed on 1st December every year. This year the theme was **“LET COMMUNITIES LEAD”**.



South 24 PG Network for People Living with HIV/AIDS (SNP+), a state level social development organization, observed World AIDS Day this year through various social mobilization activities related to the community dialogue programs at various locations in South 24 Parganas district of West Bengal. SNP+, with the support of WBSAP&CS, set up an **Information Kiosk at the Sonarpur Railway Station (Ticket Counter)**, South 24 PGS on 1st December, 2023 to bring awareness to the people as well as society about HIV/AIDS.

Activities include positive talking, condom distribution, IEC distribution, quiz competition, information on HIV/AIDS, awareness and various social mobilization activities for its prevention. Additionally, we made people aware of various initiatives taken by the government.



SNP+ organized **HIV screening cum awareness camp** from 5th to 6th Dec 2023 in **three different locations Amtala Road , Shason More , Canning Bus stand** where the SNP+ team has distributed Red Ribbons, Condom, IEC and Positive Speaking to aware people about HIV/AIDS in collaboration with WBSAP&CS with the objectives of bringing Awareness among the people about their HIV status, to provide counselling sessions on the preventions from the risk factor of HIV/AIDS, to aware the people about the use of condom and to reduce the discrimination among the people for HIV/AIDS.



## Awareness Programme through Tableau (IEC Van)

In collaboration with WBSAP&CS, SNP+ organized a **Tableau** which started from **Swasthya Bhaban** and moved to three different locations of the **South Kolkata** to bring awareness among the general population on HIV/AIDS.



SNP+ has reached around 15000 people through this activity. Where the general population is not so knowledgeable about these HIV related risk and importance of prevention. There remains a strong possibility of various high-risk behaviours. So, educating people on this is also a very important task which this IEC van has helped in imparting knowledge through various activities, such as presentation of folk songs related to HIV issues, leaflet distribution and miking.

## Community Event

A Community event has been organized at **Nari Seva Sangha, Jodhpur Park, Kolkata** on 16<sup>th</sup> February 2024 with the presence of a few of respected community persons – Debika Barua, Somnath Barui, Silk, Kusum Samanta & Nil and District Program Manager, DAPCU. The event was focussed on the discussion how the transgender communities are facing challenges and also the group of the event discussed regarding the HIV prevention strategies through the activities, such as quiz competition on HIV & Transgender community.

A health camp was also organized additional in this event as an important part and screening was done for HIV & VDRL. Clinical services have given along with the respective counselling sessions.





# Advocacy in Action



Advocacy meeting held with Panchayat Pradhan of Ramkarchar Gram Panchayat at Sagar block regarding **nutrition support through PMAY & MGNRGA** for the needy PLHIV clients and Panchayat Pradhan and Upa-Pradhan provided necessary support accordingly

Through the Advocacy meeting held with Block Medical Officer of Health at Dwariknagar Rural Hospital of Namkhana Block, SNP+ has received **support of free medicines and presence of Medical Officer and ICTC counsellor** in the health camp



Advocacy meeting with Program Coordinator of Uddami India Foundation helped to receive the support related to arrangements of vocational training for the Transgender communities. The **listed training** provided to the community population **on nursing and basic computer skill** through several workshops

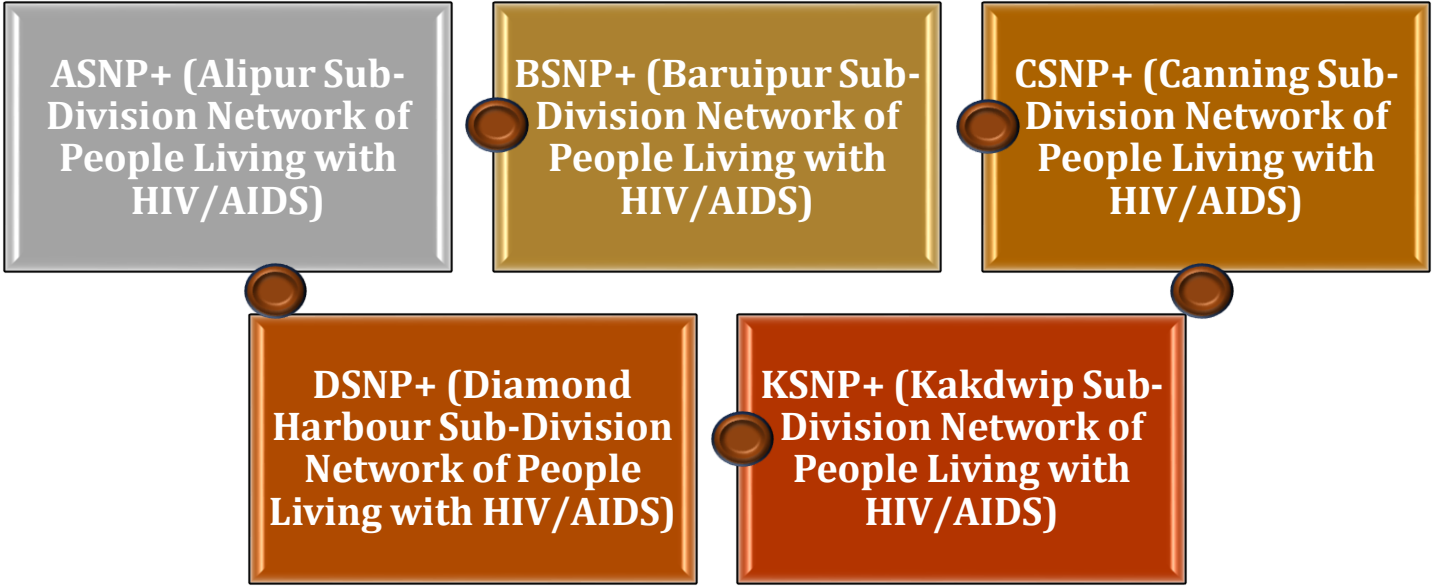

# Success Stories and Lessons

Sandeeptha Chetri, 28, has always raised her voice that she is a woman; Maybe the society is wondering what's different about it? No, so let's break it down a bit. She is a woman, but a transformed woman. There is nothing to fear or panic here. She is a human like everyone else, with two arms, legs, eyes and nose. Yes, maybe the cost of not getting is too great, but there is something to get along with. Let's talk about it. She was a bit of a sweetheart from childhood; Everyone was very nice to her. She didn't know how true it was. She was also very good in studies and hence her school results were not too bad. After school and college, of course there were many obstacles, but she was very stubborn from the beginning, so she was looking forward to overcoming the obstacles of college. Along with studies, she used to dance and modelling. She also worked in the Senco Gold Jewellery Showroom and her first release was Buddhadev Dasgupta's 'Janala' which gave her some foray into the cinema world through modelling. After that she worked in various short films like 'Ar Ek Meyar Katha', 'Uthan', 'Kalpurush'. But after all these, she suddenly didn't get any work because she is transgender. She grew up listening to all kinds of socialist crap from her childhood but she didn't give up. Now she is working with three NGOs (SNP+, Kritti and Samabona) and has stood up for transgender people and put herself forward in their service.

SNP+ works hand-in-hand with and alongside these transgenders communities to inspire them to live.

Mr. Ali is 34 years old and lives in Beniyapukur, Kolkata. He is HIV positive and on ART treatment. Due to specific TB related symptoms, he was also tested for TB and found TB positive. At the same time, his TB treatment also started. So, even though he was supposed to come to the ART centre to take his HIV medicine, he did not visit the ART centre to take the medicine. Outreach worker of SNP+, went to his house and came to know that he was admitted to police hospital due to his serious physical ailments. His physical condition was very bad, due to which he could not go to the ART centre and take the medicine. Generally, this ART medicine is prescribed to be given only to the patient, and there is no rule to send this medicine to anyone else. But after coordination with the ART centre team and higher authorities, SNP+ was successful in making arrangements to give medicines to his family members. Again, his medication was started and now he is healthy and taking his medication regularly.

## AUDITOR'S REPORT

1. We have examined the attached Balance Sheet of **"SOUTH 24 PG NETWORK OF PEOPLE LIVING WITH HIV/AIDS"** of **Milan Pally, Kalibari Lane, P.O+ P.S: Sonarpur, Kolkata-700150**, as at 31<sup>st</sup> March 2024 the related Income & Expenditure for the period from 01.04.2023 to 31.03.2024 Annexed thereto, and the Receipts & Payments Accounts for the year 31.03.2024 which we have signed under reference to the report. These financial statements are the responsibility of the management of the Society. Our responsibility is to express an opinion on these financial statements based on our audit.

2. We have conducted our audit in accordance with auditing standards generally accepted in India. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and evaluating the overall financial statements presentation. We believe that our audit provides a reasonable basis for our opinion.

3. We report that;

- We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
